Lackawanna Trail School District School Board Meeting Minutes April 12, 2021

Due to the Coronavirus Pandemic and the CDC recommendation to have groups adhere to social distance guidelines, the Lackawanna Trail School District met in person and via Zoom for a scheduled meeting, on Monday, April 12, 2021 at 7:34 pm. Public notice thereof having been given in accordance with applicable law. A mixture of live and virtual Google Executive Session was held prior to the School Board meeting from 6:32 pm to 7:25 pm. All nine board directors were present for this meeting. The following items were discussed: personnel and a legal issue.

President Mulhern called the meeting to order and called the roll.

The meeting began with an opportunity for public participation.

Approval of Minutes

Mr. Ross made a motion, seconded by Mr. Minick to approve the meeting minutes from the March 8, 2021 regular school board meeting and the April 6, 2021 Work Session meeting. The motion was approved by a vote of 7-0-1. Mr. Thorne abstained.

Bill Listing

Mr. Ross made a motion, seconded by Mr. Bianchi that all bills found to be true and accurate be approved. The motion was approved by a unanimous vote of 8-0.

<u>Treasurer's Report: February</u>

Mr. Mulhern made a motion, seconded by Dr. Mould to approve the Treasurer's Report from February 2021 as submitted. The motion was approved by a unanimous vote of 8-0.

Treasurer's Report: March

Mr. Mulhern made a motion, seconded by Dr. Mould to approve that the board approve the Treasurer's Report from March 2021 as submitted. The motion was approved by a unanimous vote of 8-0.

Tax Collector Compensation

Mr. Minick made a motion, seconded by Mr. Thorne to maintain the current Tax Collector Compensation Rates at \$3.00 per bill mailed, \$7.00 per full bill and first installment collected, \$2.50 per 2nd and 3rd installment collected. Rate will remain in

effect for 2020-2021 through 2023-24 School Years. The motion was approved by a unanimous vote of 8-0.

<u>Transportation Contract</u>

Mr. Bianchi made a motion, seconded by Ms. Naylor to approve the transportation contract with the Western Pennsylvania School for the Deaf for the 2021-2022 school year. The motion was approved by a unanimous vote of 8-0.

Tower North Contract Renewal

Mr. Bianchi made a motion, seconded by Mr. Ross to approve the Tower North contract renewal from April 30, 2021 to April 30, 2022. The motion was approved by a unanimous vote of 8-0.

Pivot Contracts

Mr. Thorne made a motion, seconded by Mr. Minick to approve the contract with Pivot for Athletic Training (\$24,600 with additional hours billed at \$24 per hour), Physical Therapy (\$105 per hour), and Occupational Therapy (\$105) for the 2021-2022 school year. The motion was approved by a unanimous vote of 8-0.

Resolution for Charter School Funding Reform

Mr. Ross made a motion, seconded by Mr. Mulhern to approve the Resolution for Charter School Funding Reform. The motion was approved by a unanimous vote of 8-0.

PlanCon Part K Approval

Mr. Ross made a motion, seconded by Dr. Mould to approve the PlanCon Part K forms for submission to the Pennsylvania Department of Education. The motion was approved by a unanimous vote of 8-0.

Flooring Replacement Bids

Mr. Bianchi made a motion, seconded by Mr. Minick to approve the solicitation of bids for flooring replacement in the Elementary Center and Junior-Senior High School. The motion was approved by a unanimous vote of 8-0.

Advertising Rates 2021-2022

Mr. Stark made a motion, seconded by Mr. Bianchi to approve the following advertising rates in the high school and elementary gyms for 2021-2022, on the recommendation of the superintendent:

- a. 3' X 4' \$250
- b. 4'X 6' \$300
- c. Annual renewal \$75

The motion was approved by a unanimous vote of 8-0.

COVID Travel Policy Update: Eliminate Out-Of-State Travel Restrictions

Mr. Minick made a motion, seconded by Ms. Naylor to eliminate the out-of-state travel restrictions, as per previously adopted policy on September 8, 2020, then revised on December 7, 2020. The Pennsylvania Department of Health has declared that the travel ban is no longer in effect. Travelers should still practice appropriate public health measures to slow the spread of COVID-19 such as masking, physical distance and hand hygiene. The motion was approved by a unanimous vote of 8-0.

The motion was approved by a unanimous vote of 8-0.
